For as little as \$5\*, children can open a passbook savings account. After this deposits of any value are welcome. Deposits are collected from your school office every week.

Account passbooks give children a visible record of their deposits so they can see their savings grow. And to encourage your child's saving, we will pay them great interest (4% p.a)\*\* and charge no fees.

Opening the account is easy. Simply cut off the form overleaf, fill it out and put it in the envelope with the \$5 initial deposit. Then just hand it in at school. We'll get a passbook out to you.
